### **2017 BUDGET MEETING**

Tentative date for the Public Budget Hearing and Special Town Meeting of the Electors is Monday, November 6, 2017. The special town meeting on the budget is where electors approve the total town tax levy. The 2018 proposed budget will be available by October 20<sup>th</sup> on the town's website and posted at the town hall.

## TDS BROADBAND UPDATE - JULY 17, 2017

TDS Phase #1 of the project is updating all of the outside plant for the broadband project. This is schedule to be completed by October 1, 2017. At that time TDS customers should start noticing better/faster broadband services.

TDS Phase #2 of the project is updating the electronics in the central office and remote locations for the broadband project to provide 25 meg down and 3 meg up broadband speeds. This will be completed prior to October, 2018. About the time that Phase #2 is completed TDS will be doing a marketing or public relations campaign advertising the higher broadband speeds. New Broadband packages with the high speeds will be rolled out then.

Town of Berry residents that do not have TDS Broadband service can call TDS in October, 2017 and see what speeds are available at their location.

## **BERRY ZONING MOVES FORWARD**

In April, Town residents, at the Annual Town Meeting, voted by a 2-to-1 margin to opt-out of Dane County Zoning. Berry and five other Dane County towns have moved forward and are in the position to now firmly expect to leave Dane County Zoning on January 1, 2018.

The Town of Black Earth, unfortunately, missed a notification deadline and will have to wait to have its vote on opting-out. Similarly, two other towns were unable to keep up with the complicated process and dropped out of the optout procedure midway through.

The new zoning ordinance is almost complete and will be up for adoption in September. Similarly, the opt-out towns have reached an agreement with CARPC to do the towns' mapping services for a nominal fee, and have also negotiated a contract with General Engineering Corporation ("GEC") of Portage to be the Zoning Administrator. GEC will be providing that service for 85% of the fees paid for the rezoning. The total fees to be paid for rezoning applications will remain the same as they were under Dane County Zoning.

The opt-out towns have also coordinated with DATCP for certification of the new ordinance, to keep farmland preservation credits in place.

Meanwhile, after years of refusing to undertake a comprehensive re-write of the Dane County Zoning Ordinance, the County has moved forward on its re-write. Part of the County's plan includes a total rezoning of all land in the county to fit newly-defined categories developed under their new ordinance. That means every town remaining in Dane County Zoning after January 1, 2018 will be rezoned in its entirety. In an ironic twist, much of the new zoning ordinance Dane County is considering draws on the previously-drafted opt-out towns' proposed ordinance. Yet, there are significant differences, especially in the area of the zoning of signs and agricultural lands.

Because the opt-out towns' new zoning ordinance grandfathers in existing ordinance classification and uses, nothing will change in Berry. The new Berry Town Zoning Ordinance will only apply to those who request a change in their zoning. In other words, if you like your zoning, you can keep it – at least in the Town of Berry.

Once the County adopts its comprehensive rewrite, other Dane County towns will have the opportunity to opt-out of Dane County Zoning. However, unlike the six towns presently involved in opting out, those towns will not be able to opt-out of Dane County Plat Review.

There is currently pending in the legislature a trailer bill to simplify the opt-out procedure. If that bill is passed, other Dane County towns may follow, regardless of the comprehensive re-write by Dane County.
